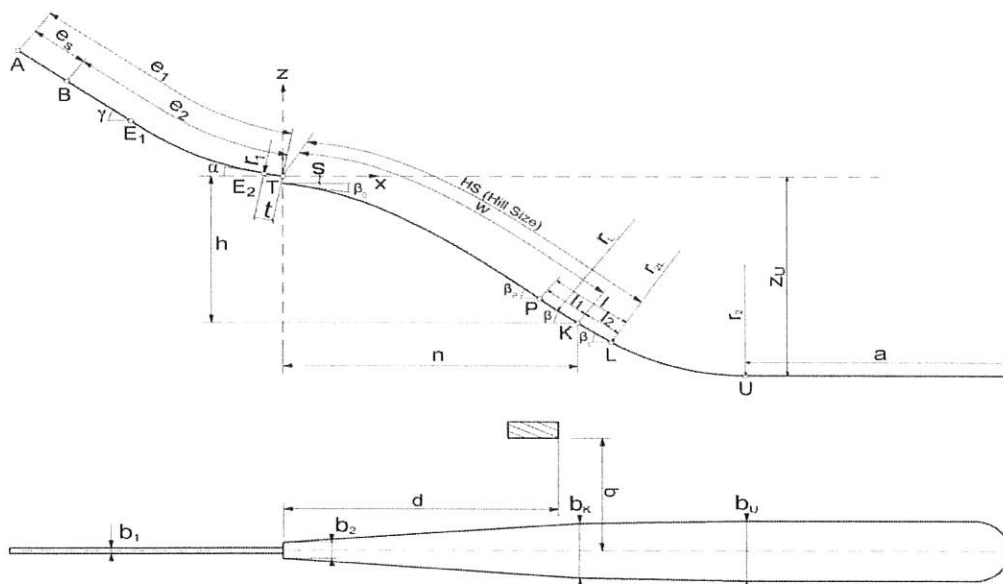


Remarks / Bemerkungen
